



Paying Participant Release of Liability Read Carefully – Signing Affects Your Legal Rights

In consideration of being allowed to participate in the following event:

Allegheny River Wilderness Sojourn, June 22-24, 2017, (“**Event**”) hosted by the Penn Soil Resource Conservation & Development Council (“**Penn Soil**”), _____ (“**Participant**”), does hereby release, remise, waive, discharge and covenants not to sue Penn Soil, their heirs, assigns, executors, administrators, directors, agents, servants, employees, partners, officers, successors in interest, insurers, other participants, sponsoring agencies, sponsors, advertisers, the owners and lessors of the premises used to conduct the event, and all other persons, firms or corporations, (“**Releasees**”) and every one of them, liable or might be claimed to be liable, of and from all, and any manner of demands, losses or damages on account of injury, including physical injury, death or damage to property, caused or alleged to be caused in whole or in part by negligence of the Releasees or otherwise, action(s), cause(s) of actions, suits, joinders for sole liability, contribution, indemnity or otherwise, sum(s) of money, accounts, specialties, covenants, contracts, agreements, promises, variances, damages, judgments, extents, executions, claims, and demands whatsoever, in law or in equity, which the said Participant has, or which his or her heirs, executors, administrators, assigns, or subrogees hereinafter can, shall or may have against Releasees in any way arising out of participation in the Event.

I, the Participant:

- acknowledge that I have been fully informed of the nature, scope and demand of the Event, and that I am in good physical health and believe that I am able, without reservation or limiting conditions, to withstand and cope with the rigors of the Event.
- understand that this activity may include rigorous outdoor activities under variable environmental conditions and that there are a number of inherent risks involved in the activity which are beyond the control of the Releasees and I agree to personally assume and appreciate such risks.
- agree to abide by the rules and regulations imposed on the participants of the Event by the Penn Soil and/or its affiliates.
- agree and understand that photographs and videos, which include my image, taken at the Event may be used by Penn Soil (a non-profit), for advertising, publicity, commercial or other business purposes. I hereby give Penn Soil permission to duplicate and distribute the photographs and videos or any parts thereof including my image in perpetuity. I waive the right to inspect or approve the finished version(s).

This Release of Liability shall be construed pursuant to the laws of the Commonwealth of Pennsylvania.

I further acknowledge that I was offered a full refund of the event fees in the event that I did not wish to sign this Release of Liability. However, I declined said refund and signed this Release voluntarily and without coercion.
